The Bollinger Foundation is named in memory of Steve Bollinger, who was Assistant Secretary for Community Planning and Development at the U.S. Department of Housing and Urban Development from 1981-1984. Steve Bollinger was a dedicated professional who passed away unexpectedly in 1984, leaving behind his wife and four young children. The Foundation was created in his memory to provide financial assistance to families of economic development, community development, and public housing workers who have lost a parent or guardian.
