White House to Host Forum on Economic Development

WASHINGTON, D.C. (July 29, 2015) The [International Economic Development Council](#) (IEDC) and [SelectUSA](#) will host the 4th annual *White House Forum on Economic Development* on Thursday, July 30, 2015. The day-long summit will feature keynote panels and breakout discussion sessions. Over 50 economic development leaders from across the country will attend and directly engage senior White House and Administration officials. Valerie Jarrett, Senior Advisor to the President and Assistant to the president for Public Engagement and Intergovernmental Affairs will provide the welcome remarks.

JoAnn Crary, CEcD, President of Saginaw Future Inc., in Saginaw, Michigan and current Chair of the IEDC Board of Directors, stressed the importance of the face time invitees get with the Obama Administration officials, saying: "There is no substitution for direct contact with program heads and policy makers. These are the decision-makers, and they need to hear from leaders in America's communities who provide new ideas and solutions."

Opening remarks will be provided by Bruce Andrews, the Deputy Secretary for the Department of Commerce. Jay Williams, Assistant Secretary of Commerce for Economic Development at the Department of Commerce will continue the morning conversation and speak about how to build stronger regional economies. Jeffrey Zients, the Director of the National Economic Council and Assistant to the President for Economic Policy will provide lunch remarks. The forum will close with a session titled *Macroeconomic Outlook on the Economy of the Future*, with speakers Mark Doms, the Under Secretary for Economic Affairs, Economic and Statistics Administration, at the Department of Commerce and Jason Miller, the Deputy Director at the National Economic Council for the White House.
